



## Address Correction - Terms and Conditions

1. These **Terms and Conditions** (hereafter referred as "T&Cs") shall be the supplementary terms and conditions of SF's [Terms and Conditions of Carriage](#). If Shipper or Receiver use Address Correction Service, these T&Cs shall apply subject to SF's Terms and Conditions of Carriage. Shipper agrees, and on behalf of the Receiver and/or any third party with an interest in the Shipment that these Terms and Conditions shall apply.
2. "Customer" herein means Shipper and/or Receiver.
3. If Customer require to change the receiving address or return the Shipment to the original shipping address before the Shipment being successfully delivered, the transit time of the Shipment will increase by several business days.
4. If Customer change the receiving address from any local address within Hong Kong S.A.R to SF Service Point within Hong Kong S.A.R (including SF Store, SF Locker and SF Cooperation Point), Address Correction Service Charge will be exempted. If the Shipment is redelivered to to-door address or returned to the Shipper (regardless of to the original shipping service point or to the original shipping address), Address Correction Service Charge will be required. If Customer change the receiving address to an address where is outside the territory of Hong Kong S.A.R, Customer shall pay another shipment charges.
5. If Customer use Address Correction Service, SF will collect the Address Correction Service Charge from Receiver when SF deliver the Shipment. Shipper shall ensure that Receiver has expressly acknowledged and agreed with this arrangement, failing which, SF shall have rights to claim Address Correction Service Charge from Shipper and/or Receiver if the Receiver refuses to pay the same.
6. Address Correction Service Charge standard is generally quoted in Hong Kong dollars. If Shipment is not paid in Hong Kong S.A.R, the charges will be converted into the currency of the payment area according to the exchange rate shown on SF's official website.
7. SF has the absolute discretion to decide whether to provide or withdraw the Address Correction Service at any time, and reserves the right to change any provisions of these T&Cs at any time without any prior notice.
8. If any provision hereof is held by any court or other authority to be invalid or unenforceable in whole or in part, the remaining provisions of these T&Cs and the remaining contents of the affected provision shall remain valid. Failure or delay in enforcing any provision under these T&Cs will not constitute a waiver of such provision.
9. These T&Cs shall be governed by and construed in accordance with the laws of the Hong Kong
